1. Welcome and apologies for Absence

2. Co-option of new councillor

3. Declarations of Interest

4. Minutes

The minutes of the meeting held on 19 November 2012 were confirmed and signed.

5. Matters Arising

A letter from the Village Hall Trustees noted that unless an event was for charitable purposes, the Parish Council must pay for the hire of the Village Hall.

9. Precept 2013/14

It was agreed that the Parish Council will continue to ask for £32,000.

10. Public Participation

Mrs Steward questioned how well the Christmas Tree Festival had gone and suggested a committee should be established for the next such event. Mr Hewson raised concerns that there

should have been tighter control on the form regarding the sale of the Christmas trees. It was suggested that the Parish Council should give a set amount of money to a committee and let the committee run the event. Any monies raised above this should then be divided among the charities taking part. Mrs Steward requested a copy of the income and expenditure for the event.

Mr Eagle explained the position regarding the hedge between Black Horse Close and Hill Rise. He said that the County Council had put the fence in the wrong position and that as a result he is unable to properly cut the hedge. He noted that he has always cut the hedge and is not ignoring his responsibilities. Mr Eagle believes that Norfolk County Council is responsible for cutting the hedge.

The Council was asked to see if there were any monies for Recreation contributions available to it from Breckland Council.

11. New Litter Bin Request

The clerk read a request for litter bins on the path through the estate from Draytonhall Lane. It was agreed to install a bin at either end, subject to Breckland Council being able to empty them.

12. Hedge Cutting from Blackhorse Close to Hill Rise

It was agreed to contact Norfolk County Council in view of Mr Eagle's comments above.

13. External Hard Drive

It was agreed to purchase an External Hard Drive for all Parish Council business.

14. Speed Control Measures on Allwood Avenue

It was agreed to contact Norfolk County Council to see what can be done about speed control measures on Allwood Avenue

15. Picnic Bench

It was agreed to purchase an additional picnic bench for the Water Meadows play area in the spring.

16. Christmas Tree Fair Donation

It was agreed that £100 should be paid to Scarning PCC in respect of the Christmas Tree Fair for the use of the church, heating and electricity. The PCC will invoice the Parish Council.

17. Water Meadows Play Area

Quotes for reseeding the goal mouth areas were read. Garden Plan were asked to quote again.

18. Management of Recreational Spaces

It was agreed to write to the Playing Field Committee asking for its accounts, in order to satisfy the Parish Council's audit requirements; to request copies of their minutes to be forwarded to the Parish Council; and for the minutes to be published on the parish website. It was also agreed to check that the Parish Council representatives are being invited to the Playing Field Committee meetings.

It was agreed to apply for funding for a footpath from Chestnut Road to Cooper Terrace.
